SUMMERLICIOUS 2019 CONTEST
RULES AND REGULATIONS

1. HOW TO PARTICIPATE

- 1.1 Eligibility: The Summerlicious 2019 Contest (“The Contest”) is open to all residents of Canada that are eighteen (18) years of age or older at the time of entry (“entrants”), except residents of Quebec, employees of Oliver & Bonacini Hospitality, and their respective parents, affiliates, subsidiaries and the immediate family members and persons living in the same household of such employees are not eligible to participate in the Contest.
- 1.2 Contest Period: The Contest begins at 11:00 a.m. Eastern Standard Time (“EST”), Friday, July 5th, 2019 and ends at 11:59 p.m. Eastern Standard Time (“EST”), Sunday, July 21nd 2019.
- 1.1 Contest Entry:
- (1) Entrants may participate in the Contest by obtaining an entry ballot by dining at a participating Oliver & Bonacini Hospitality restaurant during the contest period, completing the ballot by providing their full name and a valid email address by which the entrant can be contacted, and presenting the completed ballot to their server. Participating restaurants include: Auberge du Pommier, Bannock, Beaumont Kitchen, Biff’s Bistro, O&B Bayview Village, Canteen, Canoe, Jump, Leña, Liberty Commons, Luma, Parcheggio and R&D. Guests will be entered in a random draw for the Prize upon dining at a participating restaurant during the contest period and submitting a completed entry ballot.
- (2) No Purchase Entry: Eligible entrants may also enter the contest by sending a note with the entrant’s full name, current address, and valid email address to:

Entry is not dependant on purchase or on providing consent to receive emails from Oliver & Bonacini Hospitality.

Oliver & Bonacini Hospitality is not responsible for entries that are lost, late, misdirected, stolen, damaged, garbled, illegible, incomplete, contain inaccurate information, delayed for any reason or do not conform with or satisfy any or all of the conditions of these Rules and Regulations, as determined by Oliver & Bonacini Hospitality, in their sole and absolute discretion. Mailed no-purchase entries must bear sufficient postage, which is the sole responsibility of the entrant. Oliver & Bonacini Hospitality is not responsible for any postal delays or strikes, or delivery failures. Proof of sending a no purchase entry is not proof of receipt by Oliver & Bonacini Hospitality.

- 1.2 Future Communication: The winner of the Prize will be notified at the email address provided on the contest entry ballot. In addition, Oliver & Bonacini Hospitality may contact entrants who provided consent to receive emails (by checking the related box on the ballot) regarding future promotions and offers. These entrants may opt out of receiving emails at any time by clicking the “unsubscribe” link at the bottom of any promotional email.

- 1.4 General Rules: By participating, entrants and the randomly selected winner of the Prize accepts and agrees to comply with and be bound by these Rules and Regulations and by the decisions of Oliver & Bonacini Hospitality, whose decisions shall be final and legally binding in all respects and not subject to review in any forum, except as provided in these Rules and Regulations.

2. PRIZE

- 2.1 Prize: The Prize is a \$1,000 Oliver & Bonacini Hospitality Gift Card (“Prize”). The Prize includes the gift card, which is redeemable at all Oliver & Bonacini restaurants and may be used for multiple redemptions until it reaches its value. It may not be redeemed for cash and if lost, stolen, destroyed or used without your consent, its value cannot be replaced. A maximum of \$300 in gift card value is redeemable toward Oliver & Bonacini private events. The Prize must be accepted as awarded. No cash alternatives, substitutions or transfers of the Prize will be allowed. The Prize will be officially declared valid when the winner has correctly answered the skill testing question set out in a Declaration and Release Form and signed the Declaration and Release Form.
- 2.2 Draw and Odds: One (1) entry will be randomly selected from among all eligible entries received. The draw will occur by August 16th, 2019 at “Oliver & Bonacini Hospitality”. The odds of being selected to win the Prize depend on the total number of eligible entries submitted.
- 2.3 Winner Notification: The winner of the \$1,000 Oliver & Bonacini Gift Card (“Prize”) will be contacted by email by August 16th, 2019. The selected winner will be required to reply by e-mail within 7 days (168 hours) of notification. If the selected winner does not claim his or her Prize within 7 days (168 hours) of notification, another winner will be randomly selected and the initial winner will be disqualified with no recourse towards Oliver & Bonacini Hospitality. If terminated, Oliver & Bonacini Hospitality may, in its sole discretion, determine the winner from among all eligible Contest Entries received up to time of such action using the procedures outlined herein.
